# 交易資訊通知約定事項

### 1 名詞定義

交易資訊通知服務係指利用傳真/電子郵件傳送客戶所指定帳戶之交易資訊至客戶所指定之傳真機/電子郵件信箱之服務。

## 2 免責事由

客戶同意如有下列情事或因客戶或第三人之傳眞系統或設備/電腦或網路故障所致之資料傳輸錯誤、遺漏、延遲時,本行不負任何法律責任。

- (1). 因傳真/網際網路設備出現訊息中斷或故障等現象。
- (2). 因電路故障而延遲傳送或無法傳送,或因傳真/網際網路系統或設備過於繁忙或其他人爲及非人爲因素,使得訊息傳送錯誤。
- (3). 因所傳送的資料被截取、損毀、延遲、遺失、偽造、變造、扭曲、變形、縮小、放大、不清晰而無法辨識或甚至帶有病毒。

## 3 無損害賠償責任

客戶同意本行無須對客戶因信賴透過傳眞/網際網路設備接收之訊息或未能透過傳眞/網際網路設備接收訊 息所致之直接或間接損害,負擔任何責任及義務。

## 4 交易資訊通知服務之約定

除本行與客戶另有約定及本節所載傳送方式外,客戶瞭解並同意本行不接受其他透過傳眞/網際網路設備傳送之指示或通知,亦無須因不接受該等指示或通知,而負擔任何法律責任。

# 5 客戶之設備檢視義務

客戶爲保護自身權益,應隨時檢視傳眞設備或電子郵件信箱,確認其運作正常。



## 6 客戶之通知義務

客戶指定之電子郵件信箱或傳真號碼如有變動,應將立即以書面通知本行。因可歸責於客戶之延遲通知所致之損害,客戶應自行承擔及負責。

## 7 通知方式

客戶如欲終止或變更交易資訊通知服務內容,應以書面或其他本行接受之方式通知本行。



# Terms and Conditions for Transaction Notice

#### 1 Definition

Transaction Notice Service means a service to transmit the Customer's designated account transaction information via fax or e-mail to the Customer's designated fax or e-mail.

### 2 Waivers

The Customer agrees that the Bank shall not be held liable for the error, omission, and delay in information transmission resulting from any of the following causes or the malfunction of the Bank's or a third party's facsimile system, equipment, computer or network:

- (1). Message disruption or breakdown of facsimile/Internet equipment;
- (2). Delay or failure in transmission due to circuit failure, or error in message transmission due to facsimile/Internet system or equipment that is overloaded, or other human or nonhuman factors; and
- (3). Transmitted information is unclear and vague due to being intercepted, destroyed, delayed, lost, forged, altered, twisted, shrunk, enlarged or contains virus.

## 3 Free of Liability

The Customer agrees that the Bank is not liable for the Customer's direct or indirect loss arising from its reliance on messages received or its failure to receive messages through facsimile/Internet equipment.

#### 4 Terms for Transaction Notice Service

Except the transmission means stipulated in this Section or otherwise expressly agreed upon by the Bank and the Customer, the Customer understands and agrees that the Bank may reject other instructions or notices transmitted by facsimile/Internet equipment and assumes no responsibility for rejecting such instruction or notice.

## 5 The Customer's Liability for Equipments Examination

To protect the Customer's interest, the Customer shall examine its facsimile equipment or e-mail box from time to time to ensure the normal operation of the related equipments.



# 6 The Customer's Liability to Notice

The Customer shall immediately notify the Bank of any change of its designated e-mail address or fax number in writing. The Customer assumes sole responsibility for damages that occur as a result of delay in notice which is attributable to the Customer.

## 7 Notice Means

If the Customer intends to terminate or change this service, it shall notify the Bank in writing or in any other forms agreed by the Bank.
